

**RESOLUTION NO. 2025-042**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF PEMBROKE PARK, FLORIDA, ADOPTING AN INVENTORY LIST OF ALL REAL PROPERTY OWNED BY THE TOWN OF PEMBROKE PARK AND WHETHER SAID PROPERTY IS APPROPRIATE FOR AFFORDABLE HOUSING, ATTACHED HERETO AS EXHIBIT “A;” PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Florida Statue 166.0451 “Disposition of municipal property for affordable housing” requires the Town to prepare an inventory list of all real property within its jurisdiction to which the Town holds fee simple title which that is appropriate for use as affordable housing; and

**WHEREAS**, the inventory list must include the address and legal description of each such property and specify whether the property is vacant or improved; and

**WHEREAS**, the Town’s professional staff and consultants have provided said inventory list; and

**WHEREAS**, the Town Commission has held a public hearing pursuant to FSS 166.0451; and

**WHEREAS**, the Town Commission of the Town of Pembroke Park, Florida finds that adopting the inventory list of Town owned property set forth in Exhibit “A” to be in the best interests of the citizens and residents of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF PEMBROKE PARK, FLORIDA.**

**Section 1:** That the foregoing "WHEREAS" clause is hereby ratified and confirmed as being true and correct and is hereby made a specific part of this Resolution upon adoption hereof.

**Section 2:** That the Town Commission has held a public hearing and hereby adopts the inventory of Town owned land pursuant to FSS 166.0451, attached hereto as Exhibit "A" and being on file with the Town Planning Department, the Town website and by reference made a part hereof.

**Section 3:** That if any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way effecting the validity of the other provisions of this Resolution.

**Section 4:** That all Resolutions or parts of Resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.


**Section 5:** That this Resolution shall be effective immediately upon adoption.
