New Bus Shelter from Broward County

Broward County has been installing the new bus shelters along Hallandale Beach Boulevard and 52nd Avenue.

Meeting for Possible New Development on SW 30th Avenue

This week, the Town Planner and I met with the owner of a vacant property at 2550 SW 30th Avenue about a possible development project for that site. This project will be presented to the DRC on July 26th, 2021.

Town Hall Lobby Renovation

The engineering plans detailing the structural modifications required to move the a/c duct work in the hallway have not been completed yet. Once received the contractor will apply for the permits.

Development of the "Pembroke Oaks" Site next to Town Hall

The Town Planner and I met with the developers of the large property next to Town Hall. They are still interested in building a mixed used complex at the site and are meeting with the Town and Broward County to determine all of the requirements.

Departmental Updates

Police Department

This week, the Police Department staff attended a background investigations training and also attended the Broward Chiefs of Police meeting regarding this weekend's "Rolling Loud" Event at Hard Rock Stadium. Staff also completed three grants: Crime Prevention, Accreditation and De-Escalation with the Department of Justice.

Public Works

Carolina Pumps Oil to Water Lube Conversion The contractor continues to work on Pump No. 3 which is expected to be completed in 4-6 weeks.

CDBG 45th Year Grant – ADA Restrooms

Construction of the ADA restrooms commenced this week. The contractor is currently working on the foundation for the new restroom building. The building is being manufacture off site and will be delivered and installed via crane. The park is closed during the construction. Staff is also working with Broward County Schools to finalize the agreement to connect to their sewer lift station.

Town Hall Hardening Project and Police Department Calvin Giordano and Associates is scheduled for a site visit on July 27th.

Lift Station 15

This project has been postponed pending the completion of the electrical drawings which will be included in the bid documents. The electrical engineer indicated that the plans will be completed on or before August 7.

Finance Department

This week, Finance Director Taubenfeld and I continued working on the proposed budget.

Human Resources

This week, HR continued working on the recruitment process of police personnel as well as the other vacant positions. The new part timer in the Police Department will start on Monday.

Town Clerk

This week the Clerk's Office worked on organizing all of the old files that have met retention and will be shredded. The shredding is scheduled for Friday, July 30th.

Town Planner

This week, the Town Planner completed the DRC review for a new building at 2550 SW 30th Avenue. The DRC meeting is scheduled for July 26, 2021. Staff also met with the developers of the Pembroke Oaks site (next to Town Hall) to discuss the future development of the site.
