VALUATION:

<u>Permit valuation must be in accordance with the Florida building Code, Broward County</u> <u>Administrative Provisions (FBC-BCAP) §109.3 and 19.3.1, as follows:</u>

<u>109.3</u> Building permit valuations. The applicant for a permit shall provide an estimated permit value at a time of application. Permit valuations, shall include total value of work, including materials and labor, for which the permit is being issued, such as electrical, gas, mechanical, plumbing equipment, and permanent systems. If, in the opinion of the building official, the valuation is underestimated on the application, the permit shall be denied, unless the applicant can show detailed estimates to meet the approval of the Building Official. Final building permit valuation shall be set by the Building Official.

<u>109.3.1</u> The Building Official may require an estimate of the cost utilizing RS Means, copies of signed contract and/or other descriptive data as a basis for determining the permit fee.
